**ORDERS**

Imphal, the 4th August, 2003

No. 10(4)/COLL/99-R(Pt).—In exercise of the powers conferred by Sub-Section (2) of Section 37 of the Manipur Land Revenue & Land Reforms Act, 1960 read with the first Proviso to Rule 51 of the Manipur Land Revenue and Land Reform Rules, 1961, the Governor of Manipur is pleased to cancel Government order of even number dated 24-5-2002 and to order as follows :

- (i) The classification of land as was prevailing prior to the issue of Govt. orders No. 10(4)/COLL/99-R(Pt) dated 24-5-2002 shall continue.
- (ii) The rates of land revenue of different classes of land in respect of Imphal East, Imphal West, Thoubal and Bishnupur Districts as were prevailing on 31-12-2002 shall be increased by 100% with effect from 1-1-2003 as follows:

- (iv) Orders regarding revision of revenue rates in respect of the revenue villages in the Hill Districts will be issued separately.
